This matter is before the Colorado State Personnel Board ("Board") at its regularly scheduled meeting held on June 16, 2020. This matter is before the Board on remand from the Court of Appeals, Court of Appeals No. 17CA921. The Court of Appeals directed the Board to determine the amount of damages and to enter an award in that amount. During the meeting, the Board considered the record, including the Award of Damages entered by the Senior Administrative Law Judge on January 29, 2020.

Based upon the Board's review and consideration,

IT IS HEREBY ORDERED that the Senior Administrative Law Judge's Award of Damages is adopted, and the Order of the State Personnel Board dated April 19, 2017, is amended to include entry of an award of damages to the Complainant through January 23, 2020, in the amount of \$78,014.52, plus entry of an award of continuing lost wages and benefits. Because Respondent has not yet reinstated Complainant, the State Personnel Board cannot calculate a sum certain regarding Complainant's continuing loss.
