**ORDER OF THE STATE PERSONNEL BOARD GRANTING IN PART THE PETITION FOR HEARING**

This matter is before the Colorado State Personnel Board ("Board") at its regularly scheduled meeting held on March 17, 2020. During this public session, the Board considered the Preliminary Recommendation of the Administrative Law Judge.

Based upon its review and consideration of the Preliminary Recommendation, the Board finds there is a sufficient basis to adopt the Preliminary Recommendation of the Administrative Law Judge to grant in part the petition for hearing.

IT IS HEREBY ORDERED that the Preliminary Recommendation of the Administrative Law Judge is adopted, and that the petition for hearing is **GRANTED** in part as follows:

- (a) A hearing is granted on Complainant's whistleblower claim in Complainant's Petition No. 4;
- (b) A hearing is granted on Complainant's whistleblower claim in Complainant's Petition No. 2 as to the Rule 6-10 notice only;
- (c) A hearing is denied on the other claims in Complainant's Petition No. 2;
- (d) A hearing is denied on all other claims raised in Complainant's Petitions Nos. 1, 3, 5, 6, 8 and 10 and those claims are dismissed with prejudice;
- (e) The performance evaluation issues and the Fair Labor Standards Act issues asserted in Complainant's Petition No. 8 are referred to the State Personnel Director for review; and
- (f) The ALJ who hears the matters granted for hearing as set forth above shall decide whether the Board has jurisdiction to proceed over Complainant's whistleblower claims in Complainant's Petition No. 7.
