#### MEETING MINUTES

February 15, 2022

The State Personnel Board met on February 15, 2022. The Board held its meeting via webinar using Zoom.

The meeting was called to order at 9:00 a.m. Board Members Patricia Bangert, Kimberley Dempster, Robert Lee, David Ruchman, and Sarah Wager were present for the roll call via webinar. Rick Dindinger, Board Director, and Assistant Attorney General Amy Lopez, Board Counsel, were also present via webinar.

### I. REPORT OF THE DEPARTMENT OF PERSONNEL & ADMINISTRATION (DPA) AND REPORT OF THE DIVISION OF HUMAN RESOURCES (DHR).

Mr. Ruchman seconded the motion. The motion carried on the affirmative vote of the following Board members: Ms. Bangert, Ms. Dempster, Mr. Lee, Mr. Ruchman, and Ms. Wager. Following the vote, the Board entered into executive session. The executive session ended at 11:13 a.m.

Following the executive session, the Board resumed a public session. Mr. Ruchman was excused from the remainder of the meeting due to a prior engagement. Ms. Wager announced that the Board had received legal advice and not taken any formal action.
